Following the hearing in this application, it is ordered that:

1. Computicket shall be entitled to respond to the inclusion of 335 pages inserted in the Tribunal record on 6 October 2011, by 31 October 2011.
2. It is recorded that Computicket does not accept that the Commission has any right to reply to Computicket's response, but if the Commission wishes to apply to do so, it shall so apply by 7 November 2011.
3. The following shall be heard on 18 November 2011 -
  - 3.1 the Commission's condonation application;

3.2 the Tribunal's determination of Computicket's objection regarding whether any or all of the documentation referred to in 1 above is properly in evidence before the Tribunal; and

3.3 an application to be brought by Computicket by 26 October 2011, and to be answered by the Commission by 9 November 2011 regarding the discovery by the Commission of the report founding the referral of the complaints relating to Computicket by the Commission to the Tribunal.

4. The hearing of the dismissal application before the Tribunal is postponed to 13 December 2011.

5. All questions of costs are reserved.

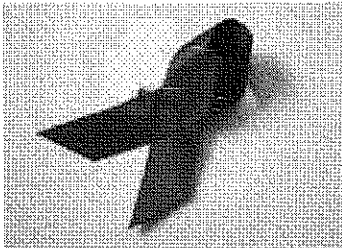
