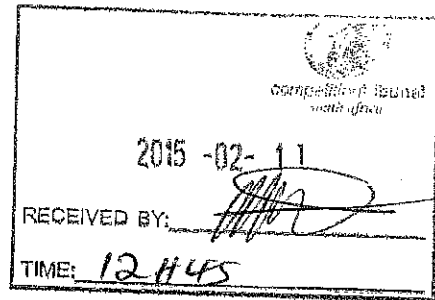

**CONSENT AGREEMENT IN TERMS OF SECTION 49D READ WITH SECTIONS 58(1)(a)(iii) AND 58(1)(b) OF THE COMPETITION ACT, 1998 (ACT NO. 89 OF 1998), AS AMENDED, BETWEEN THE COMPETITION COMMISSION AND AMSTEELE SYSTEMS (PTY) LTD IN RESPECT OF AN ALLEGED CONTRAVENTION OF SECTIONS 4(1)(b)(i), 4(1)(b)(ii) and 4(1)(b)(iii) OF THE COMPETITION ACT, 1998**

The Competition *Commission* and *Amsteele* Systems (Pty) Ltd hereby agree that application be made to the Competition *Tribunal* for confirmation of this consent agreement as an order of the Competition Tribunal in terms of section 49D as read with sections 58(1)(a)(iii) and 58(1)(b) of the Competition Act, 1998 (Act No.89 of 1998), as amended, on the terms set out below:

1. Definitions

For the purposes of this consent agreement the following definitions shall apply:

- 1.1 “**Act**” means the Competition Act, 1998 (No. 89 of 1998), as amended.
- 1.2 “**Amsteele**” means Amsteele Systems (Pty) Ltd, a company incorporated under the laws of the Republic of South Africa with its principal place of business at Germiston, Gauteng.
- 1.3 “**consent agreement**” means this agreement set out herein, duly signed by the *Commissioner* and *Amsteele*.
- 1.4 “**Commission**” means the Competition Commission of South Africa, a statutory body established in terms of section 19 of the *Act* with its principal place of business at 1<sup>st</sup> Floor, Mulayo Building (Block C), the Dti Campus, 77 Meintjies Street, Sunnyside, Pretoria, Gauteng.
- 1.5 “**Commissioner**” means the Competition Commissioner of South Africa, the Chief Executive Officer of the *Commission* appointed in terms of section 22 of the *Act*.
- 1.6 “**Complaint**” means the complaint initiated by the *Commissioner* under case number 2010Apr5034 in relation to a possible contravention of sections 4(1)(b)(i) and (iii) of the *Act*.



- 1.7 "CLP" means the Commission's Corporate Leniency Policy.
- 1.8 "SAPTA" means the South African Post Tensioning Association, an industry association for the providers of post-tensioning steel in South Africa.
- 1.9 "the Republic" means the Republic of South Africa.
- 1.10 "Tribunal" means the Competition Tribunal of South Africa, a statutory body established in terms of section 26 of the Act, with its principal place of business at 3<sup>rd</sup> Floor, Mulayo building (Block C), the dti Campus, 77 Meintjies street, Sunnyside, Pretoria, Gauteng.

**2. Background to the complaint and settlement discussions**

- 2.1 On 13 April 2010 the *Commissioner* initiated a *Complaint*, in terms of section 49B(1) of the Act, against Amsteele Tsala-RMS Construction Solutions (Pty) Ltd ("Tsala-RMS"), Freyssinet Posten (Pty) Ltd ("Freyssinet"), Steelforce Systems (Pty) Ltd ("Steelforce") and SAPTA in respect of their involvement in fixing prices and allocating tenders for the supply of post-tensioning steel in contravention of sections 4(1)(b)
- 2.2 The Commission conducted an investigation and found that Tsala-RMS, Freyssinet, Steelforce and Amsteele had entered into an agreement, arrangement and/or understanding which contravened section 4(1)(b).
- 2.3 Following from this complaint, Amsteele engaged the Commission in settlement negotiations which have culminated in this consent agreement.

### 3. Commission's findings

Upon completion of its investigation into the *Complaint*, the *Commission* found that *Amstele* had, between the period June 2006 and December 2008, reached and implemented an overarching agreement which involved:

- 3.1 Division of markets by allocating customers in contravention of section 4(1)(b)(ii) of the *Act*. This aspect of the overarching agreement was implemented by meetings and discussions between *Amstele* and its competitors, *Tsala-RMS* and *Freyssinet* to achieve an outcome of roughly equally shared available tenders for post-tensioning steel;
- 3.2 Collusive tendering in contravention of section 4(1)(b)(iii) of the *Act*. This aspect of the overarching agreement was implemented by:
  - (a) participating in meetings and discussions with competitors, *Tsala-RMS*, and *Freyssinet*, wherein they identified and allocated tenders amongst each other in the provision of post-tensioning steel, and
  - (b) submitted cover pricing bids for each other's allocated projects, and
  - (c) in so doing, achieved an outcome of indirectly price fixing by agreeing on controlled mark-ups and profit margins on tenders with a view to excluding substitutable products (and in particular reinforcing steel bar).
- 3.3 Indirectly agreeing with competitors, *Tsala-RMS*, *Freyssinet* and *Steelforce*, on industry trading terms and conditions in respect of applicable price adjustment formulae for post tensioning contracts in contravention of section 4(1)(b)(i) of the *Act*. This arrangement was reached by participating in meetings and discussions with competitors, *Tsala-RMS*, *Freyssinet* and *Steelforce*, under the auspices of *SAPTA*. The *SAPTA* members agreed upon and implemented an escalation formula and certain conditions of contract. The formula proportioned the mix of labour and materials applicable



to the post tensioning industry and applied specific indices available from Statistics South Africa.

**4. Admission of Liability**

Amsteele admits that it engaged in contravention of sections 4(1)(b)(i), 4(1)(b)(ii) and 4(1)(b)(iii) of the Competition Act, as set out in the Commission's Findings in paragraph 3 above. Amsteele, however, cannot provide the detail of all construction projects involved in the admitted conduct described in 3 above. Amsteele is able to provide the list of projects, attached as Annex "A" as Amsteele's best recollection of the projects affected by this conduct.

**5. Agreement concerning future conduct**

5.1 *Amsteele* has been candid in its engagement with the *Commission* and has provided information that has assisted the *Commission* in concluding its investigation. *Amsteele* undertakes to cooperate further with the Commission including providing information and witnesses to assist in the prosecution of the other participants in the cartel.

5.2 In so far as the Commission is aware, and has confirmed by *Amsteele*, the conduct that is the subject of this agreement has ceased and *Amsteele* undertakes not to engage in conduct that is in contravention of section 4(1)(b) of the *Act* in future.

5.3 *Amsteele* undertakes to develop and implement a compliance programme designed to ensure that its employees, management and directors do not engage in any conduct which constitutes a prohibited practice in terms of the Act, a copy of which programme shall be submitted to the Commission within ninety (90) days of the date of confirmation of this agreement as an order of the Tribunal.



**6. Administrative penalty**

6.1 In terms of section 58(1)(a)(iii) of the *Act* read with section 59(1)(a), 59(2) and (3) of the *Act*, and in order to settle the matter *Amsteele* agrees to pay an administrative penalty in the amount of R2 800 000 (Two Million Eight Hundred Thousand Rand).

6.2 The above amount is equivalent to 7% of the turnover derived from the manufacture and supply of post-tensioning steel in the financial year ending March 2011 and does not exceed 10% of *Amsteele's* annual turnover in the same year.

6.3 *Amsteele* will pay the amount set out in paragraph 6.1 above to the *Commission* in accordance with the following schedule of payments:

6.3.1 The first payment of R1 000 000.00 (One Million Rand) to be paid within 30 days of the Tribunal order.

6.3.2 The second and final payment of R1 800 000.00 (One Million Eight Hundred Thousand Rand) to be paid on the first anniversary of the first payment.

6.4 The penalty amount is to be paid into the bank account of the *Commission*. The *Commission's* banking details are as follows:


6.5 The *Commission* will pay the penalty amount into the National Revenue Fund in accordance with section 59(4) of the *Act*.

This *Agreement* is entered into in full and final settlement and upon confirmation thereof as a consent order by the *Tribunal* concludes all proceedings between the *Commission* and *Amsteele* relating to *its* involvement in the conduct that is the subject of the *Complaint* under case number: 2010Apr5034.
