On 4 February 2011, Air Products was granted conditional immunity in terms of the CLP, for its involvement, *inter alia*, in concluding and implementing the 2000 Agreement. On 20 April 2011, the Commissioner initiated the Complaint in terms of section 49B(1) of the Act against the Parties, for an alleged contravention of section 4(1)(b)(ii) of the Act.

After investigating the Complaint, the Commission came to the view, *inter alia*, that, by concluding the 2000 Agreement, the Parties had allocated the liquid CO2 market to Afrox and the gaseous CO2 market to Air Products in contravention of section 4(1)(b)(ii) of the Act,

Without conceding that, in relation to the 2000 Agreement, it has contravened section 4(1)(b)(ii) of the Act, Afrox has agreed to amend the 2000 Agreement as set out hereunder.
