**CONSENT AGREEMENT IN TERMS OF SECTION 49D AS READ WITH SECTIONS 58(1)(a)(iii) AND 58(1)(b) OF THE COMPETITION ACT, 89 OF 1998, AS AMENDED, BETWEEN THE COMPETITION COMMISSION AND STUTTAFORDS VAN LINES (PTY) LTD; PICKFORDS REMOVALS SA (PTY) LTD; AND AGS FRASER INTERNATIONAL (PTY) LTD IN RESPECT OF CONTRAVENTIONS OF SECTION 4(1)(b)(i) AND (iii) OF THE COMPETITION ACT, 1998.**

## **PREAMBLE**

The Competition Commission ("Commission") and Stuttafords Van Lines (Pty) Ltd ("Stuttafords"); Pickfords Removals SA (Pty) Ltd ("Pickfords"); and AGS Fraser International (Pty) Ltd ("AGS"), operating subsidiaries of Laser Transport Group (Pty) Ltd, hereby agree that application be made to the Competition Tribunal ("Tribunal") for the confirmation of this Consent Agreement as an order of the Tribunal in terms of section 49D read with section 58(1)(a)(iii) and 58(1)(b) of the Competition Act, No. 89 of 1998, as amended, ("the Act") in respect of contraventions of section 4(1)(b)(i) and (iii) of the Act, on the terms set out below.

## **1. DEFINITIONS**

For the purposes of this Consent Agreement, the following definitions shall apply:

- 1.1 **"Act"** means the Competition Act, No. 89 of 1998, as amended;
- 1.2 **"AGS"** means AGS Fraser International (Pty) Ltd, a private company duly incorporated in accordance with the laws of the Republic of South Africa, with its principal place of business situated at 2<sup>nd</sup> Street, Midrand, Gauteng.
- 1.3 **"AGS Complaint Referral"** means the complaint referred by the Commissioner to the Tribunal against AGS under Tribunal case number CR025May15.
- 1.4 **"Commission"** means the Competition Commission of South Africa, a statutory body established in terms of section 19 of the Act, with its principal place of business at Mulayo Building (Block C), the DTI Campus, 77 Meintjies Street, Sunnyside, Pretoria, Gauteng;
- 1.5 **"Commission 2017 Complaint"** means a complaint initiated by the

Commissioner of the Competition Commission on 3 October 2017 under case number: 2017Oct0012 against members of the Professional Movers Association (PMA), including Stuttafords, Pickfords, Magna, Sandton and AGS for fixing insurance premium rates for short and long-distance furniture removal services.

- 1.6 **"Commissioner"** means the Commissioner of the Commission, appointed in terms of section 22 of the Act;
- 1.7 **"Complaints"** means four distinct complaints initiated by the Commissioner. The first complaint (the Stuttafords Complaint) was initiated under case number 2010Nov5547. The second complaint (the Pickfords and AGS Complaint) was initiated under case number 2011Jun0069. The third complaint (the Commission 2015 Complaint) was initiated under case number 2015Jul0442. The fourth complaint (the Commission 2017 Complaint) was initiated under case number 2017Oct0012.
- 1.8 **"Complaint Referrals"** means the AGS Complaint Referral, the Pickfords Complaint Referral, and the Stuttafords Complaint Referral.
- 1.9 **"Consent Agreement"** means this agreement duly signed and concluded by and between the Commission and the Respondents;
- 1.10 **"Laser Group"** means Laser Transport Group (Pty) Ltd, a company duly registered and incorporated in accordance with the laws of the Republic of South Africa. Stuttafords, Pickfords, AGS, Magna and Sandton are wholly owned subsidiaries of the Laser Group and are implicated in matters that form a subject of the Complaints.
- 1.11 **"Magna"** means Magna Thomson (Pty) Ltd, a private company duly incorporated in accordance with the laws of the Republic of South Africa, with its principal place of business situated at 2 Jacaranda Street, Lordsvue,

Midrand.

- 1.12 **"Parties"** means the Commission, Stuttafords, Pickfords, AGS, Magna and Sandton.
- 1.13 **"Pickfords"** means Pickfords Removal SA (Pty) Ltd, a private company duly incorporated in accordance with the laws of the Republic of South Africa, with its principal place of business situated at Halfway House, Cnr 2<sup>nd</sup> Road & Setter Street, Midrand, Industrial Park, Gauteng.
- 1.14 **"Pickfords and AGS Complaint"** means the complaint initiated by the Commission on 01 June 2011, under case number: 2011Jun0069, where Pickfords and AGS are listed among the respondents or firms which engaged in prohibited practices.
- 1.15 **"Pickfords Complaint Referral"** means the complaint referred by the Commissioner to the Tribunal against Pickfords under Tribunal case number CR129Sep15.
- 1.16 **"Respondents"** means Stuttafords, Pickfords and AGS.
- 1.17 **"Sandton"** means Sandton Office Removals (Pty) Ltd, a private company duly incorporated in accordance with the laws of the Republic of South Africa, with its principal place of business situated at 2 Oak Road, Lordsvue, Midrand.
- 1.18 **"Stuttafords"** means Stuttafords Van Lines (Pty) Ltd, a private company duly incorporated in accordance with the laws of the Republic of South Africa, with its principal place of business situated at 23 Axle Drive, Clayville, Olifantsfontein, Midrand.
- 1.19 **"Stuttafords Complaint"** means the complaint initiated by the Commission on 3 November 2010, under case number: 2010Nov5547 where Stuttafords is listed as one of the firms which engaged in prohibited practices.

1.20 **"Stuttafords Complaint Referral"** means the complaint referred by the Commissioner to the Tribunal against Stuttafords under Tribunal case number CR130Aug17.

1.21 **"Tribunal"** means the Competition Tribunal of South Africa, a statutory body established in terms of section 26 of the Act, with its principal place of business at Mulayo building (Block C), the DTI Campus, 77 Meintjies Street, Sunnyside, Pretoria, Gauteng.

## **2. COMMISSION'S INVESTIGATIONS AND FINDINGS ON FURNITURE REMOVAL COMPANIES**

2.1 Between November 2010 and June 2013, the Commissioner initiated investigations against several furniture removal companies, including Stuttafords, Pickfords and AGS for possible collusive practices as regards price fixing, market division and collusive tendering in contravention of section 4(1)(b) (i), (ii) and (iii) of the Act, in the market for the provision of furniture removal services.

2.2 The Commission's investigation(s) revealed that furniture removal companies concluded agreements and/or engaged in concerted practices to tender collusively in the provision of furniture removal services to government departments, big corporates, and private individuals. The collusion appears to have occurred from 2007 to at least 2012.

2.3 The collusion between the furniture removal companies entailed exchanging of cover prices/quotes. In terms of the cover price/quote arrangement(s), a firm that was contacted first by a customer requesting quotation for furniture removal services would offer to source two or more quotations on behalf of the customer and would then contact two or more of its competitors and request the

competitors to submit cover prices. The cover prices would either be sent directly to the customer or to the competitor wishing to win the tender for onward submission to the customer.

- 2.4 The Commission investigated and referred three separate complaints to the Tribunal for adjudication against Stuttafords, Pickfords and AGS.

**3. COMMISSION'S INVESTIGATION AND FINDINGS IN RESPECT OF THE STUTTAFORDS COMPLAINT**

- 3.1 The Commission's investigation found that Stuttafords had multiple bilateral arrangements with each of Cape Express, JH Retief, De Langes and Patrick Removals in terms of which they exchanged cover quotes in respect of six hundred and forty-nine (649) furniture removal tenders.

- 3.2 A list of instances of collusion implicating Stuttafords in collusive arrangements with each of Cape Express, JH Retief, De Langes and Patrick Removals is attached to this consent agreement marked "**Annexure A1**".

- 3.3 The conduct described above amounts to price fixing and/or collusive tendering which contravene section 4(1)(b)(i) and/or (iii) of the Act.

**4. COMMISSION'S INVESTIGATIONS AND FINDINGS IN RESPECT OF THE PICKFORDS AND AGS COMPLAINT**

- 4.1 The Commission's investigation found that Pickfords engaged in multiple bilateral arrangements with each of Sifikile, Cape Express and JH Retief in terms of which they exchanged cover prices/quotes in respect of thirty-seven (37) furniture removal tenders.

- 4.2 The Commission's investigation found that AGS engaged in bilateral arrangements with JH Retief in terms of which they exchanged cover

prices/quotes in respect of three (3) furniture removal tenders.

- 4.3 A list of instances of collusion implicating AGS in three collusive arrangements with JH Retief is attached to this consent agreement marked "**Annexure A2**".
- 4.4 A list of instances of collusion implicating Pickfords in collusive arrangements with each of Sifikile, Cape Express and JH Retief is attached to this consent agreement marked "**Annexure A3**".
- 4.5 The conduct described above amounts to price fixing and/or collusive tendering which contravenes section 4(1)(b)(i) and/or (iii) of the Act.

## **5. COMMISSION INVESTIGATION AND FINDINGS IN RESPECT OF THE COMMISSION 2017 COMPLAINT**

- 5.1 The Commission's investigation found that members of the Professional Movers Association (PMA), including Stuttafords, Pickfords, Magna, Sandton and AGS, engaged in prohibited practices, in contravention of the Act, by fixing insurance premium rates in respect of short and long-distance furniture removal services.
- 5.2 The Commission concluded that the conduct described above amounts to price fixing and/or collusive tendering which contravenes section 4(1)(b)(i) and/or (iii) of the Act.

## **6. ADMISSION OF LIABILITY AND TERMS OF SETTLEMENT**

- 6.1 Stuttafords admits liability in respect of the prohibited practices described in the Stuttafords Complaint and the Stuttafords Complaint Referral.
- 6.2 Pickfords admits liability in respect of the prohibited practices described in the Pickfords and AGS Complaint and the Pickfords Complaint Referral.
- 6.3 The Commission has agreed that as part of the settlement of the Complaints,



the Commission withdraws from the Tribunal the AGS Complaint Referral and the prosecution of AGS in respect of the three instances in which AGS has been implicated in terms of the Pickfords and AGS Complaint.

- 6.4 The Consent Agreement concludes and finalises all complaints, investigations and prosecutions against Stuttafords, Pickfords, Magna, Sandton and AGS in terms of the Stuttafords Complaint, the Pickfords and AGS Complaint, the Commission 2015 Complaint and the Commission 2017 Complaint.

## **7. FUTURE CONDUCT**

- 7.1 Stuttafords and Pickfords agree and undertake to:
- 7.1.1 prepare and circulate a statement summarising the contents of this Consent Agreement to their employees, managers, and directors within thirty (30) days of the date of confirmation of this Consent Agreement as an order of the Tribunal.
  - 7.1.2 refrain from engaging in conduct in contravention of section 4(1)(b) of the Act in future;
  - 7.1.3 continue to implement and monitor their existing competition law compliance programmes as part of their corporate governance policies, which are designed to ensure that their employees, management, directors, and agents do not engage in future contraventions of the Act; and
  - 7.1.4 submit a copy of such compliance programme to the Commission within thirty (30) days of the date of confirmation of this Consent Agreement as an order by the Tribunal.

## **8. ADMINISTRATIVE PENALTY**

- 8.1 Having regard to the provisions of sections 58(1)(a)(iii) as read with sections 59(1)(a), 59(2) and 59(3) of the Act, Stuttafords and Pickfords are jointly and severally liable to pay an administrative penalty, the one paying the other to be absolved, as follows:
- 8.2 Stuttafords and Pickfords agree and undertake to pay a cumulative administrative penalty in the amount of R 40 000 000,00 (Fourty Million Rand) in full and final settlement of all matters currently pending before the Tribunal.
- 8.3 Stuttafords and Pickfords will pay R 40 000 000.00 (Fourty Million Rand), in full and final settlement, upon confirmation of this Consent Agreement as an order of the Tribunal.
- 8.4 The administrative penalty must be paid into the Commission's bank account which is as follows:

- 8.5 The administrative penalty will be paid over by the Commission to the National Revenue Fund in accordance with the provisions of section 59(4) of the Act.

**10. FULL AND FINAL SETTLEMENT**

This agreement, upon confirmation as an order of the Tribunal, is entered into in full and final settlement of all conduct related to prohibited practices engaged in by Stuttafords, Pickfords, Magna, Sandton and AGS and concludes all proceedings between the Commission and the Respondents in respect of the Complaints.


