**ORDER**

---

1. After having heard the parties in this application and with reference to the discovery schedule attached to this order as "ANNEXURE A", the Competition Tribunal ("Tribunal") orders as follows:

2. General Items:

2.1. The application in respect of general item 1 is upheld. The respondents are ordered to discover documentation for the period 2012-2017 where outstanding and applicable. For clarity this time period also applies to items 3; 40; 41; 43; 51; and 52.

2.2. The application in respect of general item 2 is denied. The respondents are ordered to discover any outstanding 'final' documentation only, unless otherwise tendered.

2.3. In respect of general item 3, the Tribunal orders the discovery of only those documents tendered by the merging parties. For clarity, this entails the respondents discovering documents, in addition to their own documents, for (i) the South African operating companies; and (ii) the operating companies that principally manage trade on the principal South African routes- being those routes between South Africa and Europe as well as between South Africa and East Asia, where applicable. Insofar as the items requested in general item 3 fall beyond the merging parties' tender, the application is denied.

2.4. In respect of general item 4, the Tribunal orders the discovery of only those four categories of documents in relation to the car carrier market and bulk shipping market tendered by the respondents under numbering 1 on page 45 of the attached schedule. Insofar as an item under general item 4 falls beyond the tender made by the respondents, the application for its discovery is denied.

2.5. In respect of general item 5, the respondents are required to submit a discovery affidavit under oath, as tendered, at the conclusion of the provision of documents in respect of this discovery order.

### 3. Specific items

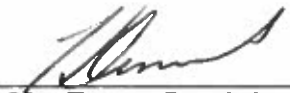
3.1. The application for the discovery of items listed under items 1; 2; 3; 4; 5; 6; 7; 8; 9; 10; 11; 12; 13; 14; 15; 16; 19; 21; 22; 23; 24; 25; 26; 27; 28; 29; 30; 32; 33; 34; 36; 39; 44; 47; 50; 51; 52; 54; and 56 insofar as such are not contained in the respondents' tender, as expanded by 2.1 above is denied.

3.2. The application for the discovery of items listed under item 40, insofar as such is limited by 2.1-2.4 above is granted.

3.3. The application for the discovery of items listed under items 41 and 43 is denied.

4. Discovery is to be completed within 10 business days of this order.

1 The Merger Parties will provide the following categories of documents in response to the Commission's requests for documents in relation to the car carrier market and the bulk shipping market -

1.1 market research reports in respect of the car carrier market and the bulk shipping market;

1.2 total global revenues and profitability for the most recent financial year for the Merger Parties' car carrier and bulk shipping divisions;

- 1.3 the top ten global customers for each of the Merger Parties for car carrier and bulk shipping for their most recent financial year; and
- 1.4 documents reflecting the major cost items of the Merger Parties in relation to their respective car carrier and bulk shipping businesses for the most recent financial year.

**Commission response to the above four categories:**

The Commission does not accept the tender that these documents are the only documents that are relevant to the car carrier and bulk shipping markets. As such the Commission persists with its request that the merging parties provide the requested documents for the car carrier and bulk shipping markets as indicated in the second column above.

If the merging parties intend pursuing this line of argument in their expert report or elsewhere then the Commission would necessarily require the documents, through discovery, that pertains to the merging parties' argument. Such discovery does not replace the Commission's requests but would be in addition to the Commission's requests (seeing as the merging parties may intend relying on documents relevant to these four categories).
