**CONSENT AGREEMENT BETWEEN THE COMPETITION COMMISSION AND  
VASILIS SUPERMARKET CC TRADING AS VASILIS CLEANING SUPPLIES IN  
RESPECT OF AN ALLEGED CONTRAVENTION OF SECTION 8(1)(a) OF THE  
COMPETITION ACT 89 OF 1998, AS AMENDED, READ WITH REGULATION 4  
OF THE CONSUMER AND CUSTOMER PROTECTION AND NATIONAL  
DISASTER MANAGEMENT REGULATIONS AND DIRECTIONS PUBLISHED IN  
GOVERNMENT GAZETTE NO 43116 ON 19 MARCH 2020**

The Competition Commission and Vasilis Cleaning Supplies hereby agree that application be made to the Competition Tribunal for the confirmation of this Consent Agreement as an order of the Tribunal in terms of section 49D of the Competition Act 89 of 1998, as amended ("**the Act**"), in respect of a contravention of section 8(1)(a) of the Act read together with Regulation 4 of the *Consumer And Customer Protection And National Disaster Management Regulations And Directions* published in Government Gazette No 43116 on 19 March 2020, as well as the *Regulations on*

*Competition Tribunal Rules for COVID-19 Excessive Pricing Complaint Referrals* published in Government Gazette No 43205 on 3 April 2020 and the *Tribunal Directive for Covid-19 Excessive Pricing Complaint Referrals* on the terms set out below:

## 1 DEFINITIONS

The following words shall, unless otherwise stated or inconsistent with the context in which they appear, bear the following meanings in this Consent Agreement:

- 1.1 "**Act**" means the Competition Act 89 of 1998, as amended;
- 1.2 "**Commission**" means the Competition Commission of South Africa, a statutory body, established in terms of section 19 of the Act, with its principal place of business at Building C, Mulayo Building, the dti Campus, 77 Meintjies Street, Sunnyside, Pretoria, Gauteng;
- 1.3 "**Commissioner**" means the Commissioner of the Competition Commission, appointed in terms of section 22 of the Act;
- 1.4 "**Consent Agreement**" means this agreement duly signed and concluded between the Commission and Vasilis Cleaning Supplies;
- 1.5 "**Consumer Protection Regulations**" means the Consumer and Customer Protection and National Disaster Management Regulations

and Directions published in Government Gazette No 43116 on 19 March 2020;

- 1.6 **"Disaster Management Act"** means the Disaster Management Act, 57 of 2002;
- 1.7 **"Relevant Products"** means black Nitrile surgical gloves, blue Nitrile surgical gloves, dust masks (FFP1), dust masks (FFP2), latex gloves, latex gloves (powder-free), and surgical masks;
- 1.8 **"Tribunal"** means the Competition Tribunal of South Africa, a statutory body, established in terms of section 26 of the Act, with its principal place of business at Building C, Mulayo Building, the dti Campus, 77 Meintjies Street, Sunnyside, Pretoria, Gauteng;
- 1.9 **"Tribunal Directive for Covid-19 Excessive Pricing Complaint Referrals"** means the directive issued by the Tribunal on 6 April 2020;
- 1.10 **"Tribunal Rules for COVID-19 Excessive Pricing Complaint Referrals"** means the Regulations on Competition Tribunal Rules for COVID-19 Excessive Pricing Complaint Referrals published in Government Gazette No. 43205 on 3 April 2020; and
- 1.11 **"Vasilis Cleaning Supplies"** means Vasilis Supermarket CC trading as Vasilis Cleaning Supplies, a close corporation duly incorporated in accordance with the laws of the Republic of South Africa with registration

number B1992009084 and its registered place of business at 180 Paul Kruger Avenue, Universitas, Bloemfontein, South Africa.

## 2 BACKGROUND AND CONTEXT

- 2.1 On 15 March 2020, given the magnitude and severity of the COVID-19 outbreak which had been declared a global pandemic by the World Health Organisation (WHO) and classified as a national disaster by the Head of the National Disaster Management Centre, the Minister of Co-operative Governance and Traditional Affairs ("**COGTA**") declared a State of National Disaster in the Republic of South Africa which declaration was published in Government Notice No. 313 of Government Gazette No. 430096.
- 2.2 On 18 March 2020, the Minister of COGTA issued regulations ("**Disaster Management Regulations**") published in Government Notice No. 318 of Government Gazette No. 43107, regarding the steps necessary to prevent an escalation of the disaster or to alleviate, contain and minimize the effects of the disaster. These regulations were made in terms of section 27(2) of the Disaster Management Act. Paragraph 10(6) of the Disaster Management Regulations authorised the Minister of Trade and Industry to, *inter alia*, issue directions to protect consumers from excessive, unfair, unreasonable or unjust pricing of goods and services during the national state of disaster.

2.3 On 19 March 2020, the Minister of Trade and Industry published the Consumer Protection Regulations. The purpose of the Consumer Protection Regulations is to promote concerted conduct to prevent an escalation of the national disaster and to alleviate, contain and minimise the effects of the national disaster and to protect consumers and customers from unconscionable, unfair, unreasonable, unjust or improper commercial practices during the national disaster.

2.4 In relation to excessive pricing, the Consumer Protection Regulations states the following:

*"4. Excessive Pricing.*

*4.1. In terms of section 8(1) of the Competition Act a dominant firm may not charge an excessive price to the detriment of consumers or customers.*

*4.2. In terms of section 8(3)(f) of the Competition Act during any period of the national disaster, a material price increase of a good or service contemplated in Annexure A which –*

*4.1.1. does not correspond to or is not equivalent to the increase in the cost of providing that good or service;*  
*or*

*4.1.2. increases in net margin or mark-up on that good or service above the average margin or mark-up for that good or service in the three-month period prior to 1 March 2020.*

*is a relevant and critical factor for determining whether the price is excessive or unfair and indicates prima facie that the price is excessive or unfair."*



- 2.5 Annexure A lists the goods and services that fall to be regulated by the Consumer Protection Regulations.
- 2.6 On 23 March 2020, the President of the Republic of South Africa announced the enforcement of a nationwide lockdown for 21 days with effect from midnight on Thursday, 26 March 2020.
- 2.7 On 3 April 2020, the Tribunal Rules for COVID-19 Excessive Pricing Complaint Referrals were published and thereafter, on 6 April, the Tribunal Directive for Covid-19 Excessive Pricing Complaint Referrals was issued.
- 2.8 On 9 April 2020, the President of the Republic of South Africa announced an extension of the enforced nationwide lockdown by a further two weeks, until the end of April 2020. The lockdown has subsequently been further extended.

### 3 THE COMMISSION'S INVESTIGATIONS AND FINDINGS

#### *Investigation*

- 3.1 In April 2020, the Commission received information in terms of section 49B(2)(a) of the Competition Act, regarding excessive prices charged by the Respondent for, *inter alia*, surgical gloves, surgical masks, and dust masks.

- 3.2 Facial masks and surgical gloves fall under the category of 'medical and hygiene supplies' in Annexure A of the Consumer Protection Regulations. Regulation 4 of the Consumer Protection Regulations is therefore applicable to the conduct described in this Consent Agreement.
- 3.3 In terms of Section 7(c) of the Act, market power can also be inferred from the economic behaviour of the firm. In this case, the mere ability to raise prices is indicative of market power as it demonstrates a lack of constraints such that there is an ability to control prices and/or behave independently of competitors and customers.
- 3.4 States of disaster often provide the conditions for temporary market power to be held by market participants that may not otherwise have market power outside of the disaster period. The removal of constraints may occur for several reasons, many of which are conceptually related to a narrowing of the geographic market for products as a result of disruptions to the normal functioning of markets. In the context of abnormal market conditions amid the Covid-19 crisis, a firm's own conduct therefor is the best available proxy for market power if the market is distorted by the crises.
- 3.5 In a state of national disaster, an established test within the assessment of excessive pricing under the Act is determining whether price increases have a corresponding cost justification. This is because an excessive profit margin is detectable if the ordinary prices are increased materially absent cost increases.

## ***Findings***

3.6 The Commission conducted an investigation into Vasilis Cleaning Supplies alleged conduct and found the following:

3.6.1 Vasilis Cleaning Supplies is based in Bloemfontein and sells online, amongst others, cleaning products, safety and disposable products and medical care products, and offers nationwide distribution. It has a store located at 16 Loop Street Bloemfontein.

3.6.2 Vasilis Cleaning Supplies is a wholesaler that services all business in the cleaning and hygiene industry. Their focus is on providing cleaning products to a range of different customers including cleaning contractors, hospitals, entrepreneurs, and retailers.

3.6.3 Vasilis Cleaning Supplies does not manufacture any of its own products but rather sources products from a number of different suppliers. Vasilis procures its products from both South African manufacturers as well as importers which import the products from various foreign manufacturers.

3.6.4 Vasilis Cleaning Supplies sells, amongst other types, nitrile gloves. These gloves are made from nitrile rubber or synthetic latex. Nitrile rubber is also known as Krynac, Europrene or

Nipol. These gloves are commonly found and used in hospitals and/or similar institutions by healthcare workers in the performance of their day to day duties. Vasilis also supplies powdered and unpowdered latex gloves.

3.6.5 Disposable gloves offer protection against bacteria and viruses. There are different types of disposable gloves. For example, nitrile gloves are classified as non-latex gloves and are highly durable and puncture resistant. Since the global outbreak of COVID-19, nitrile gloves have been used, along with other disposable gloves, such as latex gloves, to protect human beings from germs and viruses. Disposable gloves have been identified as critical in alleviating, containing, and minimising the effects of the national disaster.

3.6.6 Vasilis Cleaning Supplies also supplies a variety of face masks, including surgical masks, FFP1 and FFP2 dust masks. Face masks constitute another category of essential products that are used in high volumes to combat the spread of COVID-19 in South Africa. A face mask is a flexible and disposable device that creates a physical barrier between the mouth and nose of the wearer. This product is generally used for personal comfort against non-toxic particulates. Since the outbreak of COVID-19, face masks have been used to protect human beings from airborne particles, germs, and respiratory diseases. Face

masks have also been identified as critical in alleviating, containing, and minimising the effects of the national disaster.

3.6.7 The onset of Covid-19 and the shortages around various Personal Protective Equipment ("PPE") products, not least of which are surgical gloves and face masks, within the medical and/or healthcare profession has led to a surge in demand for these products locally as a form of PPE.

3.6.8 The Commission's findings relate exclusively to the FFP1 and FFP2 dust masks, surgical masks, blue and black nitrile gloves, and latex gloves (powdered and unpowdered) sold by Vasilis Cleaning Supplies.

Surgical gloves

3.6.9 The surgical gloves relevant to this Consent Agreement are black nitrile gloves, blue nitrile gloves and latex gloves (powdered and unpowdered) sold by Vasilis Cleaning Supplies.

3.6.10 Based on pricing and cost information supplied by Vasilis Cleaning Supplies in relation to black nitrile gloves<sup>1</sup> the Commission found the following:

<sup>1</sup> Vasilis supplies four sizes of black nitrile gloves – small, medium, large and extra-large. The analysis conducted below relies on volume weighted averages across the four sizes outlined above.

- 3.6.10.1 On 19 March 2020 Vasilis Cleaning Supplies increased its prices even though cost prices were reduced over this period. Specifically, the volume weighted average selling price of black nitrile gloves ranged between R68 and R90 between December 2019 and February 2020. In March, this volume weighted average price increased from R130.43 on 19 March 2020 to R173.91 on 24 March 2020
- 3.6.10.2 In terms of costs, the average cost of all sizes of black nitrile gloves was R [REDACTED] for the period December 2019 to February 2020. From 28 February to 24 March, the cost price of all sizes reduced to R [REDACTED]. Vasilis Cleaning Supplies however increased prices in the period in which their average costs experienced a decrease.
- 3.6.10.3 The Commission considered the monthly weighted average gross profit margins for black nitrile gloves. The calculated weighted average gross profit margin showed an increase to [REDACTED]% in April 2020 (this was previously [REDACTED]% in March 2020) as compared to the average [REDACTED]% earned in the period December 2019 to February 2020.

3.6.11 Based on pricing information supplied by Vasilis Cleaning Supplies in relation to blue nitrile gloves<sup>2</sup> the Commission found the following:

3.6.11.1 A consideration of the prices of Vasilis Cleaning Supplies reveals that between 6 March 2020 and 20 March 2020, Vasilis effected a number of price increases for blue nitrile gloves across all customer groups. The pricing movements during this period were as follows:

3.6.11.1.1 Before 6 March 2020, the average selling price across all sizes amounted to R80;

3.6.11.1.2 On 6 March 2020 Vasilis Cleaning Supplies however increased the price to R110;

3.6.11.1.3 On 17 March 2020, Vasilis further increased prices (from R110) to R150; and

3.6.11.1.4 On 20 March 2020 Vasilis Cleaning Supplies again increased prices (from R150) to R200.

3.6.11.1.5 On 24 March 2020, Vasilis Cleaning Supplies reduced the prices (from R200) to R150.

3.6.11.2 In terms of costs, the average cost of all sizes of blue nitrile gloves was R [REDACTED] for the period December 2019 to February 2020. On or about 24 March 2020, the cost

of large and medium blue nitrile gloves increased to R [REDACTED], while the cost of small and x-large nitrile gloves reduced to R [REDACTED].

3.6.11.3 The average gross profit margin earned on blue nitrile gloves during the period of December 2019 to February 2020 ([REDACTED]%) was compared to the average gross profit margin during the period of March 2020. The Commission found the weighted average gross-profit margin increased to amount to [REDACTED]% in respect of blue nitrile gloves.

3.6.12 Based on pricing information supplied by Vasilis Cleaning Supplies in relation to latex gloves the Commission found the following:

3.6.12.1 *Powdered latex gloves.* The Commission found that:

3.6.12.1.1 The volume weighted average selling price of all powdered latex gloves was R54.54 for the period December 2019 and February 2020. In March, the weighted average price increased to R64.92. On 20 April 2020, the price invoiced for medium powdered latex gloves was R173.91.

3.6.12.1.2 In terms of costs, the cost of medium, large and ex-large powdered latex gloves averaged between R [REDACTED] for the period December 2019 and April 2020. For the period December 2019 and February 2020, the price of small powdered latex gloves was R59.95 and decreased to R48.90 for March and April.

3.6.12.1.3 The average gross profit margin earned during the period of December 2019 to February 2020 ([REDACTED]%) was compared to the average gross profit margin during the period of March 2020 to April 2020 and the Commission found the gross profit margin to amount to [REDACTED]% in March 2020 and [REDACTED]% in April 2020 in respect of powdered latex gloves.

3.6.12.2 *Powder free latex gloves.* The Commission found that:

3.6.12.2.1 The volume weighted average selling price of powder free latex gloves was R56.74 and increased to R99.88 in March 2020. In April, the weighted average price further increased to R144.73.

3.6.12.2.2 In terms of cost, the cost of all powder free latex gloves was R [REDACTED] for the period December 2019 and February 2020. On or about 12 March 2020 the cost price increased to R [REDACTED]. The cost price further increased to R [REDACTED] on or about 17 April 2020.

3.6.12.2.3 The average gross profit margin during the period of December 2019 to February 2020 ([REDACTED]%) was compared to the average gross profit margin during the period of March 2020 to April 2020. The Commission found that the average gross profit margin increased to [REDACTED]% in March 2020 and [REDACTED]% in April 2020 in respect of powder free latex gloves.

### Masks

3.6.13 The masks relevant to this Consent Agreement are surgical masks, FFP1 dust masks and FFP2 dust masks sold by Vasilis Cleaning Supplies.

3.6.14 Based on pricing information supplied by Vasilis Cleaning Supplies in relation to surgical masks the Commission found the following:

3.6.14.1 The volume weighted average selling price of surgical masks was R38.33, R25 and R42.70 for the period December 2019, January 2019 and February 2020 respectively. In March 2020, the price increased to R391.30 and further increased to R611.29 in April 2020.

3.6.14.2 In terms of cost, the cost of surgical masks was R [REDACTED] for the period December 2019 and January 2020. In February, the cost increased to R [REDACTED] and in March it further increased to R [REDACTED]. In April 2020, the cost reduced slightly to R [REDACTED].

3.6.14.3 The average gross profit margin during the period of December 2019 to February 2020 ([REDACTED]%), but a decline was seen in March 2020 ([REDACTED]%). The gross margin however increased again in April 2020 to [REDACTED]%.

3.6.15 Based on pricing information supplied by Vasilis Cleaning Supplies in relation to FFP1 dust masks the Commission found the following:

3.6.15.1 Between December 2019 and January 2020, the selling price of FFP1 (20s) dust masks ranged between R56 and R69.57. On or around 06 February 2020, the selling price increased to R113.04. On 19 February 2020 the

Commission found that one customer was invoiced at R210 for the masks.

3.6.15.2 Vasilis Cleaning Supplies costs for FFP1 dust masks increased from R [REDACTED] in January 2020 to R [REDACTED] in February 2020.

3.6.15.3 On 16 March 2020, Vasilis Cleaning Supplies' selling price increased from R113.04 to R425. On 18 March 2020, two customers in particular were charged R608.70 per unit. At this point in time, the comparative cost price was still at R [REDACTED].

3.6.15.4 On 19 March 2020, the cost increased to R [REDACTED]. On 20 March 2020, one customer invoice for FFP1 masks was R739.13.

3.6.15.5 The weighted average gross margin earned on FFP1 masks for the period December 2019 to February 2020 is calculated to be [REDACTED]%. However, in March 2020 an increase in the average gross margin took place increasing to [REDACTED]%.

3.6.16 Based on pricing information supplied by Vasilis Cleaning Supplies in relation to FFP2 dust masks the Commission found the following:

3.6.16.1 In January 2020, Vasilis Cleaning Supplies charged between R67 and R78 for FFP2 masks (20's). On 6 February 2020, the price increased to R130.44. On 30 January 2020, the comparative cost was R[REDACTED]. On 05 February 2020 the cost increased to R[REDACTED]

3.6.16.2 Vasilis Cleaning Supplies sold no FFP2 mask in March and April 2020. As such, the gross margins which the Commission considered were for the months of January 2020 and February 2020. As indicated below, there is an increase in gross margins observed in February 2020 with an increase from [REDACTED]% in January 2020 to [REDACTED]% in February 2020.

3.6.16.3 The average gross profit margin during the period of January 2020 ([REDACTED]%) was compared to the average gross profit margin during February 2020. The Commission found the overcharge to amount to [REDACTED]% in February 2020.

### Conclusion

3.7 The Commission found that the conduct by Vasilis Cleaning Supplies of excessively escalating margins on surgical gloves and masks without corresponding increases in costs, during the period of February to April

2020, is a contravention of section 8(1)(a) of the Act read together with Regulation 4 of the *Consumer Protection Regulations*.

- 3.8 Vasilis Cleaning Supplies does not admit that its conduct constitutes a contravention of the Act.

#### 4 AGREEMENT REGARDING FUTURE CONDUCT

Vasilis Cleaning Supplies agrees to:

- 4.1 immediately desist from pricing excessively by reducing its gross profit margins applicable to the sale of the Relevant Products to a maximum of 20% with immediate effect for the duration of the state of the national disaster;
- 4.2 donate essential goods amounting to a total value of R243,148.70 (two hundred and forty three thousand, one hundred and forty eight Rand, seventy cents) in accordance with "Annexure A" to the following beneficiaries:
- 4.2.1 The Mangaung Society for Care of the Aged situated at 5529 Maleleka Street, Bochabela, Mangaung, 9307;
- 4.2.2 Boiketlong Old Age Home situated at 4701 Lenyatso Nyaredi road, Thaba Nchu, 9780.

4.2.3 Hearts2Hands Foundation situated at 103 Besselsen Street,  
Universitas, Bloemfontein, 9301.

4.3 contribute an amount of R44,128.51 (forty four thousand, one hundred and twenty eight Rand, fifty one cents) in the form of a cash donation to the Solidarity Fund using the following bank account details:

4.4 effect the donations in paragraphs <sup>E-5</sup>~~0~~<sup>4.2</sup> and 4.3 above within 14 calendar days of confirmation of this Consent Agreement as an order of the Tribunal;

4.5 within 7 calendar days of effecting the abovementioned donations, submit an affidavit under oath by the owner of Vasilis Cleaning Supplies testifying that the donations have been made;

4.6 develop, implement and monitor a competition law compliance programme incorporating corporate governance designed to ensure

that its employees, management, directors and agents do not engage in future contraventions of the Act. In particular, such compliance programme will include a mechanism for the monitoring and detection of any contravention of the Act;

- 4.7 submit a copy of a compliance programme to the Commission within 60 business days of the date of confirmation of the Consent Agreement as an order by the Tribunal;
- 4.8 circulate a statement summarising the content of this Consent Agreement to all management and operational staff employed at Vasilis Cleaning Supplies within 7 calendar days from the date of confirmation of this Consent Agreement by the Tribunal; and
- 4.9 within 7 calendar days of circulating the summary of the Consent Agreement as envisaged in clause 4.8 above, submit an affidavit under oath by the owner of Vasilis Cleaning Supplies testifying that the summary was so circulated.

## 5 FULL AND FINAL SETTLEMENT

This Consent Agreement, upon confirmation as an order by the Tribunal, is entered into in full and final settlement and concludes all proceedings between the Commission and Vasilis Cleaning Supplies relating to any alleged contravention of section 8(1)(a) the Act read together with Regulation 4 of the *Consumer and Customer Protection and National Disaster Management*

Regulations and Directions published in Government Gazette L.0 43-115 on 19 March 2020 that is the subject of the Commission's investigation under Commission Case No. 2020Apr0032.
