## **ORDER – Extension Application and application in terms of section 14A(3) of the Competition Act.**

Having heard the parties and by agreement with the parties, the Tribunal orders as follows:

1. The Merging Parties will revert to the Commission on 21 July 2011 regarding the further information requested by the Commission.

2. The Commission is granted an extension of time up until 26<sup>th</sup> July 2011 to file its recommendation.
3. The Commission must serve a copy of the non-confidential recommendation on the South Africa Commercial, Catering and Allied Workers Union (SACCAWU) by no later than 27<sup>th</sup> July 2011;
4. SACCAWU, if it wishes to make representations regarding the merger, may do so at the hearing, provided it files a brief statement of its suggested recommendation and the basis therefore. This statement must be filed with the Tribunal and served on the Commission and the legal representatives of the merging parties, by no later than 16h00 on 29<sup>th</sup> July.
5. The abovementioned merger will be heard by the Tribunal on 1 August 2011 at 10h00.

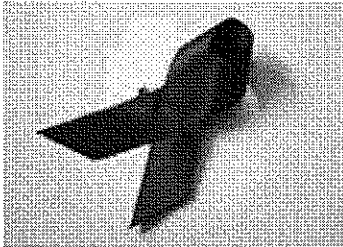
